

- With ground damages being an important liability to the industry, we aim to complement the current lack of international standards with thorough and comprehensive above-the-wing ramp safety guidelines that promote best-in-class operations.

#### WINNING A SEAT AT THE TABLE

The volume and burden of legislation governing the food and aviation sectors is increasing steadily. ACA ensures that its members aren't passive rule-takers but are actively involved in the shaping of new rules and regulations that are relevant for the in-flight catering industry. By joining ACA, you can make sure that your voice is heard when the future of the industry is discussed:

- We made sure the concerns of the industry were heard by the European Commission when crafting EU Directive 2019/904 on single-use plastics and the definition of polymers in its ensuing guidelines. We continue to monitor the implementation of any similar legislation in the world and intervene if/when appropriate.
- Together with IATA, we have crafted a unique and comprehensive template agreement that proposes legal wording on many aspects - Nominated Products, liability, termination of contract, force majeure but also SLA, etc. - acceptable to both Parties.



## BUILDING OUR REPUTATION AND BOOSTING OUR VISIBILITY

ACA is determined to advance the collective interests of its members and build the reputation of the airline catering industry. With an increasing awareness of the industry's contribution to flying and the wider economy, it is crucial for airline caterers to come together to influence and share that story - in person, through the media and social media or at industry events
